#### **NYSCAR Launches New Website**

We hope you have had the opportunity to visit NYSCAR.org which was launched in October!

The home page features links to a membership directory, membership information and applications, current and past newsletters, calendar, chapter information, officers and links to pertinent sites.

The home page also features a "member login" area. In order to log in to the member login screen, click on the Member Login link on the home page and enter your email address and password: (Password is case sensitive). All <u>REALTOR®</u> and <u>Affiliate</u> members received a letter via email with your password. If you forget your password you can retrieve from the link on the login screen. There is also a link for changing your password.

You will need to allow pop-ups for the NYSCAR.org site in order to see the login screen.

When you log in you can:

- 1. Send a broadcast email to the entire NYSCAR member list including uploading a file such as a JPG photo or a PDF flyer.
- 2. Opt in or out of the broadcast list at the bottom of the broadcast column.
- 3. Read announcements for NYSCAR members only.
- 4. Create bio information for your NYSCAR contact page
- 5. Access NYSCAR members only documents such as listing forms,

NYSCAR bylaws, etc.

6. Register for classes and pay your dues (you will need your NRDS#, which is on your pocket card from NYSAR)

The NYSCAR member directory provides the public with a way to contact you through your personalized spam-proof email screen. This includes your contact information plus your bio information (if you create it as mentioned


#### NYSCAR Members Receive the Prestigious CCIM designation
